This has been priced at \$453,799.00. That is extremely expensive but vital to the town. All our town vehicles fuel up there, the school buses, the ambulances, and the fire trucks to name a few.

DISCUSSION: LOCAL ORDINANCE LIMITING TOWN PARK EVENING ACTIVITIES

Supervisor Wood stated: this comes up every few years. The Town of Schroon does not have an ordinance that limits the time of the park or a noise ordinance. It is something we can look into. We can talk to our town attorney about it and we can start doing some research on how other towns handle this. Enforcement is always going to be the problem.

DISCUSSION: INTRODUCTION ON 3/9/26 – LOCAL LEGISLATION REGARDING OVERNIGHT CAMPING IN PUBLIC PLACES

Supervisor Wood stated: this is just a reminder that we have a Public Hearing on May 11th at 5:45 regarding the proposed Local Law that prohibits overnight camping in public places like the park. If there is no objection at the Public Hearing the Board will vote on the law.

The latest thing that we have been working on is the DOT sent us information that they need 800Sq Ft of the park. Some of that area will be permanent retention, some will be temporary just for the project.

Anthony Bonacio stated: we are on a timeline, we have weddings lined up and this work will obstruct the driveway, we wanted to get this started well before any of our big event scheduled so it doesn't interfere or impede traffic. I brought an engineer with me, to be able to answer any questions that you may have.

Chief Ritchings stated: the whole thing about it is they want to drill across route 99 into the main. If that goes array, that will take out the south side of town. We will have to shut the pump station off. The depth of the main is believed to be about 5

feet but the exact depth is unknown. The top of the man hole is 5 and a half feet but the forced main, I do not know. I am putting this in front of the board because, I do not know. We can roll the dice.

Councilperson Miller stated: so, the point is that we are afraid they are going to hit something because we don't know where it is.

Chief Ritchings stated: yes. Everything could go fine or it could go bad, the other thing is there is a water main on the other side as well that has to be drilled under.

Supervisor Wood stated: so, what kind of precautions are being put in place should there be an unfortunate outcome.

Councilperson Miller stated: first of all is there a way to prevent or to find the pipe?

Engineer stated: if the depth is not known we can use GPR, ground penetrating radar. That can be done, that will locate the depth of the lines and the depth of all the utilities. Depending on the depth of the line will determine if we go above or below.

Councilperson Gero stated: I was just going to ask what are your requirements for depth.

Engineer stated: a minimum of 5 feet. Also, with the directional drilling they can tell where the drill is and the depth along there while it is drilling. If it is determined that the forced main is 5 feet deep, as well drill with the bore, we can tell if we are 5 feet, 6 feet, 7 feet, so that will determine what we do.

Councilperson Gero stated: so, the contractor that you use with the gpr, that will be at your cost correct?

Anthony Bonacio Representative stated: oh of course. All this is at my cost, if we hit the line, that will be at my cost.

Councilperson Gero stated: I am assuming you talked to DOT and have all the permits.

Anthony Bonacio stated: yes.

Chief Ritchings stated: if that satisfies the board then I am fine with that.
